U.S VISA INTERVIEW QUESTIONS

- What is the purpose of your visit to [destination country]?
- Have you been to [destination country] before? If yes, how many times and when?
- How long do you plan to stay in [destination country]?
- Where will you be staying during your visit? (For tourist visas)
- What is your educational background and qualifications? (For student and work visas)
- Do you have any relatives or friends in [destination country]? If yes, provide their names and relationship to you.
- What ties do you have to your home country that would compel you to return after your visit?
- What do you do for a living in your home country? (For work visas)
- How do you plan to fund your trip/stay in [destination country]?
- Can you show proof of financial support for your trip? (For tourist visas)
- Are you currently employed? If yes, where do you work, and what is your position? (For work visas)
- What are your intentions after your visit? Will you return to your home country?
- Have you ever been refused a visa to any country before? If yes, provide details.
- Are you married? If yes, does your spouse intend to travel with you?
- Do you have any immediate family members living in [destination country]? If yes, provide their names and relationship to you.
- Have you ever been involved in any criminal activities or convicted of a crime?
- Have you ever violated the terms of a visa or overstayed your permitted time in any country?

USCIS MARRIAGE-BASED INTERVIEW QUESTIONS

- How did you and your spouse meet? Describe your relationship history.
- When and where did you get married? Who attended the wedding?
- Can you provide details about the wedding ceremony and reception?
- What is your spouse's full name, date of birth, and place of birth?
- How long have you been married?
- Do you live together? If yes, describe your living arrangements.
- What are your spouse's daily habits and routines?
- Can you name your spouse's parents and any siblings?
- How do you share household responsibilities and finances?
- What did you do to celebrate your last anniversary or your spouse's recent birthday?
- Describe your spouse's work or occupation and any recent professional achievements.
- How do you spend your weekends or free time together?
- Can you share details of any recent trips or vacations you took together?
- Do you have joint bank accounts or insurance policies?
- How do you communicate with each other when apart?
- Have you met each other's extended family members? If yes, describe the interactions.
- What are your future plans together as a couple?
- How did you propose or decide to get married?
- Can you show any photographs or mementos from your relationship or wedding?
- Have you encountered any challenges as a couple, and how did you handle them?

CONSULAR PROCESSING INTERVIEW QUESTIONS

- How did you meet your spouse? Describe the circumstance, include when, where, what and who.
- Is your spouse a naturalized U.S citizen? If yes, What country is your spouse originally from? How long have they been living in the U.S?
- Where does your spouse live? Know the complete address and know where your spouse, parents and siblings reside.
- How often do you and your spouse communicate? State how often you guys communicate and what communication systems you guys use for example, email, phone calls, texting, and letters.
- When was the last time you saw your spouse in person, prior to this interview?
- What do you like about your spouse?
- What are your spouse's hobbies and interests?
- When is your spouse's birthday?
- What is your spouse's religious background? Does your spouse speak and understand your language?
- Have you met your spouse's family members? Describe the circumstance and who you met. If any siblings, state their names and age.
- What do your spouse's parents think about the marriage? Did they approve it?
- Do you and your spouse have any children? If yes, state their names, ages and where they are living. If they are not in the filing, the officer will then ask if you or the petitioner intend on filing for the children. If there are no children, the officer will then ask if you plan to have children with your spouse?

CONSULAR PROCESSING INTERVIEW QUESTIONS CONT..

- Have you or your spouse ever been divorced? If yes, when did you or your spouse get divorced? Why did you and your spouse's prior marriages end? State the reason and give the officer the divorce decrees and current marriage license.
- Did you or your spouse have any prior convictions? If yes, what did you or your spouse get convicted for and describe the circumstance. Show your police reports to the officer.
- Have you ever been to the U.S? If yes, what type of visa did you use, how long did you stay and when did you return from the U.S?
- What does your spouse do for a living? Know the company, title, how long they have been employed, what job they did prior and educational background.
- What is your current job title? If unemployed, show receipts that your spouse supports you.
- Do you plan to get a job in the U.S or attend school? At this point sell yourself to the officer, share your skills, talents and goals.

IMMIGRATION INTERVIEW DO'S & DON'TS

An immigration interview is a crucial step in the immigration process, and it's important to approach it with preparation and professionalism. Here are some do's and don'ts to keep in mind for your immigration interview:

Do's:

Prepare Thoroughly: Research the specific requirements of the immigration process and the type of visa you're applying for. Understand the documents you need to bring and the questions you might be asked.

Arrive Early: Aim to arrive at the interview location well ahead of your scheduled time. This shows your commitment and punctuality.

Dress Appropriately: Dress in formal attire that reflects professionalism. This creates a positive first impression.

Don'ts:
